• **Support Example 1: Form A**

- Purchase & take possession for consumption -

Sale Weight	249 lbs.
Price bid per pound	\$2.25
Amount exhibitor receives	\$560.25
(Price bid) x (Sale weight)	
Beginning price per pound	\$0.62
Buyer contribution	\$405.87
((Price bid) - (Beginning price)) x (Sale weight)	
Support cost to buyer	\$560.25

• **Support Example 2: Form A**

- Purchase but NOT TAKE POSSESSION of animal -

Amount exhibitor receives	\$560.25
(Price bid) x (Sale weight)

Beginning price per pound	\$0.62
Buyer contribution	\$405.87
((Price bid) - (Beginning price)) x (Sale weight)	
Support cost to buyer	\$405.87
