Canyon County 4-H/FFA Resale Swine Lottery Registration

A lottery will take place for market swine animals whose buyer has opted for Support Approach #2 (they do not take possession of the animal). People who wish to participate must register with the Canyon County Extension Office to purchase animal(s) through a random drawing. The following conditions apply:

- Participants will <u>not</u> get to choose any specific animal. Swine will be randomly drawn and assigned to names on the list until all animals are drawn or requested quantity is reached, whichever occurs first.
- The order in which the registrations are received will determine the rank of participants for the drawing. The first swine number drawn will be given to the first registration received and so forth.
- Participants are not guaranteed an animal. Participants who draw an animal will be <u>required to accept animal</u>.
 Market Livestock Sale Committee (MLSC) will email participants the day after the sale to notify whether or not they have drawn an animal(s). The MLSC reserves the right to refuse registrations at their discretion.
- Participants are responsible for all costs associated with butchering. Participants will choose a butcher from the list at the bottom of the page and will pay butcher directly for butcher services. Animal(s) will be delivered to choice of butcher below for no additional charge.
- Butcher will contact participants that were drawn for cut & wrap instructions.
- Participants may sign up for multiple animals but will only receive multiples after all names on the list have received one animal.
- Participants agree to pay the swine lottery price (live animal weight times price per pound as determined and set by the MLSC) of animal(s) drawn.
- Participants who do not provide their complete billing address, email, and phone number will not be added to register. All information must be <u>legible</u> for participation.
- Participants who receive an animal will be billed by the MLSC for the swine lottery price.
- Payment due <u>in full</u> upon receipt of invoice. Failure to pay within 15 days may result in legal action and /or denial for participation in future lotteries.
