

Canyon County Fair Junior Livestock Show

ELIGIBILITY:

Each exhibitor must be a member, in good standing, of the Fair Junior Livestock Program, a 4-H club, or FFA chapter in **Canyon County**. Exhibitors must declare their organization at declaration and entry deadlines. **EXCEPTION:** Ada County 4-H and FFA members may exhibit market livestock, breeding livestock (except horse) and small animals. **EXCEPTION:** FFA members that are Canyon County residents (but not members of a Canyon or Ada County FFA chapter) and denied entry to the Owyhee County Fair may exhibit market livestock, breeding livestock and small animals. Proof of Canyon County residency and proof of official denial from the Owyhee County Fair are required.

ONLINE DECLARATIONS

The purpose of declarations is to gather data on each animal for identification purposes. Declarations also serve as verification that animals intended for exhibition at the 2024 Canyon County Fair are in possession of the exhibitor.

All market species and horses will declare through a self-declaring, online process. A declaration does not mean your animal is entered for the Canyon County Fair. Declarations are not required for breeding animals and small animals. All Fair entries are due by June 17, 2024 in order to show.

There is no limit for the number of animals that can be declared. Animals may be any breed or combination of breeds.

DECLARATION INSTRUCTIONS

The following fees are collected at declaration: insurance fees are \$15 for beef, and \$5 for sheep, goat, and swine; admin fees are \$5 per market animal.

Declaration Photo Instructions (required for beef, sheep, goat, and swine).

- Upload three, colored photos with the declaration.
 - The first photo should be the full view (head shot) of the animal with exhibitor and CCF tag in full view. Beef, Sheep and Goats should be front view and Swine should be taken from above.
 - The second and third photos should be the full right and left side profile views of the animal with the exhibitor included.

Declaration PDF Document Requirements:

- For Market Animals: Market Animal Declaration Form, Drug Affidavit Form, and Animal Caretaker Promise Form
- For Horse: Horse Declaration Form

ONLINE FAIR ENTRIES

All exhibitors who wish to show at the Canyon County Fair must have an online Fair entry recorded in his/her name in order to be eligible to show. Simply having a declaration in an exhibitor's name is not sufficient. Exhibitors will only be eligible to show the number of animals he/she has entered in online Fair entries.

All applications for entry must be made on the Canyon County Fair's website via the online entry system. Entries are \$10 per entry for large animals and \$5 per entry for small animals. Entries must be made on or before June 17, 2024 by midnight. Each space in the online entry application must be fully completed. Late entries will be accepted through June 24, 2024 for an additional \$50 fee (one time fee). Please retain a copy of your ShoWorks receipt for your personal records.

Exhibitors making entries and not exhibiting shall forfeit all fees paid.

RESPONSIBILITY OF THE FFA ADVISOR OR 4-H ORGANIZATIONAL LEADER

It is the responsibility of the FFA Advisor or 4-H Organizational Leader to certify all entries in their chapter or club are correct to the best of their knowledge.

You may weigh-in/declare, show, and sell **one** market animal per year at one Fair (either Ada or Canyon).

ALL Market Animals:

- **Market Animal Declaration form is required and will be collected at declaration for all market animals. Form can be found at: canyoncountyfair.org**
- **Limit 2 Market Head at Fair for Beef, Swine, Sheep, and Meat Goat**
- **Limit 1 Market Pen of 3 at Fair and an *Additional Showmanship Bird* for Market Broilers**

BEEF

- Declaration Due: Monday, February 26, at <https://canyonsale.fairwire.com>
 - Recommended Weight: 775-875 lbs.
- Final Weigh-In: Tuesday, July 23, 7:00 - 8:00 p.m. at the Canyon County Fair
 - Final Minimum Weight (to sell): 1,050 lbs.

SWINE

- Declaration Due: Monday, April 15, at <https://canyonsale.fairwire.com>
 - Recommended Weight: 75-90 lbs.
- Final Weigh-In: Wednesday, July 24, 6:00 - 9:00 a.m. at the Canyon County Fair
 - Final Minimum Weight (to sell): 220 lbs.

SHEEP/MEAT GOAT

- Declaration Due: Monday, May 13, at <https://canyonsale.fairwire.com>
 - Recommended Weight: Sheep - 60-70 lbs., Market Goats - 30-40 lbs.
 - Scrapies Tags are Required for all Ewes and Does
 - Tattoos are Required for all Does
- Final Weigh-In: Wednesday, July 24, 10:30 a.m. - 1:00 p.m. at the Canyon County Fair
 - Final Minimum Weight (to sell): Sheep - 110 lbs., Market Goats - 65 lbs.

MARKET BROILER

- Declaration Due: Monday, April, 8 by 4:30 p.m. at the Canyon County Fair
- Chick Pick-up: Wednesday, May 22, 9:00 a.m. - 6:00 p.m. at Dunlap Hatchery
- Final Weigh-In: Wednesday, July 24, 4:00 - 4:45 p.m. at the Canyon County Fair
 - Final Minimum Weight (to sell): 7 lbs./bird
