FAIR ADMISSION INFORMATION

LIVESTOCK EXHIBITOR ADMISSION

Cloverbud livestock exhibitors will receive two (2) Fair admission tickets for each species they are entered in. All other livestock exhibitors will receive two (2) Fair admission wristbands. Admission wristbands are good for admission each day of the Fair. **Wristbands will be packaged per exhibitor** and will be available to pick up in the Livestock Show Office (downstairs, Fair Building) beginning Monday, **July 7**.

4-H VOLUNTEER/FFA ADVISOR ADMISSION

4-H Volunteers & FFA Advisors of livestock exhibitors entered into the Fair may purchase an admission wristband for \$15.00, good for admission each day of the Fair. Admission wristbands may be purchased online www.canyoncountyfair.org or in the Livestock Show Office (downstairs, Fair Building). Admission wristbands must be purchased prior to the Fair opening (July 24). After the Fair starts, 4-H Volunteers & FFA Advisors will be required to pay full price at the gate (\$8 daily).

LIVESTOCK EXHIBITOR PARENT/GUARDIAN ADMISSION

Parents and guardians of livestock exhibitors entered into the Fair may purchase an admission wristband for \$15.00, good for admission each day of the Fair. Admission wristbands may be purchased online www.canyoncountyfair.org or in the Livestock Show Office (downstairs, Fair Building). Admission wristbands must be purchased prior to the Fair opening (July 24). After the Fair starts, parents and guardians will be required to pay full price at the gate (\$8 daily).

- Visit the Livestock Show Office or www.canyoncountyfair.org between **June 17 - July 18**. Wristbands will be available to pick-up between **July 7-18** in the Livestock Show Office (downstairs, Fair Building).

General Rules & Information

1. Canyon County Fair Management reserves the final and absolute right to interpret these rules and regulations, and settle and determine all matters, questions, and differences in regard thereto, or otherwise arising out of, connected with, or incident to the Fair.
2. Exhibitors are required to familiarize themselves with all rules. Exhibitors or their representatives failing to comply with any of these rules are subject to forfeiture of all awards and could lead to immediate dismissal from Fair and/or not being allowed to exhibit in future Fairs.
3. Disrespect shown to any judge or Fair official by an exhibitor or their representative will result in forfeiture of all awards made to the offending exhibitor and that person and/or their representatives will be asked to leave the Fairgrounds.
4. No literature may be distributed on the Fairgrounds or in the buildings unless permission has been given by Fair Management.
5. The only animals allowed on the Fairgrounds are livestock entered in the Fair and service animals. Service animals are defined as dogs that are individually trained to do work or perform tasks for people with disabilities.
6. All exhibitors, parents and adults working with youth must follow their organization's code of conduct.
7. **LIABILITY** - Exhibitor/owner of livestock/horses/exhibits assumes all risk and responsibility for loss, theft, and damage to his/herself or his/her property, or injury to any person or the property of any person by animal, while the animal/exhibit is on the Fairgrounds. The owner or custodian of property of any kind brought to the Fairgrounds whether for exhibit or for other purposes assumes, as a condition of its admission to the Fairgrounds, all risk of and responsibility for loss, damage, or theft. Exhibitor exempts the Canyon County Fair, its officers, directors and employees from liability for any loss, damage, or injury to any person or the property of any person or any animal owned or exhibited by him/her and shall indemnify the said Canyon County Fair against all claims and any injuries or damages arising from actions or negligence of the exhibitor.
8. **CAMPING** - Overnight camping or parking is not permitted on any portion of the Fairgrounds or surrounding area. You may reserve camping space at the Ambassador RV Resort located at 615 Smeed Parkway, Caldwell. Call 208-454-8584 to make reservations.
9. Refer to specific department for additional rules.

ELIGIBILITY

10. Each exhibitor must be a member, in good standing, of the Fair Junior Livestock Program, a 4-H club, or FFA chapter in **Canyon County**. Exhibitors must declare their organization at declaration and Fair entry deadlines.
 - Canyon County Fair Junior Livestock Program - Youth must be 8 to 18 years old as of January 1, 2025 and must reside in Canyon County. Contact the Canyon County Fair Office at 208-455-8500 for information and enrollment.
 - The Bucket Calf Program is open to youth ages 5 to 8 years old as of January 1, 2025.
 - 4-H Participation - An individual must be 8 to 18 years old at the beginning of the calendar year (January 1, 2025).
 - 4-H Cloverbuds (5 to 7 years old on January 1, 2025) are eligible to exhibit small animals in the showmanship class only. This class is participation only and applies to cavies, dogs (that weigh less than the exhibitor), mini goats, poultry, pygmy goats, and rabbits.

4-H Cloverbuds may not be involved in large animal projects, competitive situations, and projects involving firearms or motorized vehicles.

- FFA Participation - FFA members must have completed one year of Ag Science Education to be an exhibitor at the Fair.

EXCEPTION: Ada County 4-H and FFA members may exhibit market livestock, breeding livestock (**except horse**) and small animals.

EXCEPTION: FFA members that are Canyon County residents (but not members of a Canyon or Ada County FFA chapter) and denied entry to the Owyhee County Fair may exhibit market livestock, breeding livestock and small animals. Proof of Canyon County residency and proof of official denial from the Owyhee County Fair are required.

11. Members who enroll in both FFA and 4-H may have their 4-H projects as part of their FFA SAE projects. However, on declarations and on Fair entries it must be clearly stated if they will exhibit in 4-H or FFA. Members may not show the same project for both 4-H and FFA at the same contest/fair/show.
12. Entries may be made in only those projects in which the member is currently enrolled.

ENTRY REQUIREMENTS

13. **DECLARATIONS** - All market species and horses must declare through a self-declaring, online process. Declarations are not required for breeding animals and small animals. The following fees are submitted with declarations: insurance fees of \$15 for beef, \$5 for goat, sheep and swine; admin fees of \$5 per market animal. **LATE DECLARATIONS WILL NOT BE ACCEPTED.**
14. **ENTRY DEADLINES** - Livestock entries must be submitted online by Monday, June 16. Entry fees of \$10 per large animal (Beef Cattle, Dairy Cattle, Dairy Goat, Meat Goat, Sheep, Swine), \$15 for Horse, and/or \$5 per small animal (Cavy, Dog, Poultry, Pygmy Goat, Rabbit) must be submitted with entries. Late entries will be accepted through Monday, June 23 with an additional \$50 late fee (one-time fee). It is the responsibility of the FFA Advisor or 4-H Organizational Leader to certify all entries in their chapter or club is correct to the best of their knowledge by June 30.
15. Exhibitors must maintain continuous ownership, possession and provide daily care for each animal entered into the show from the time of declaration until show day.
16. All livestock must be entered in a quality class except for dog, horse and Cloverbud projects.
17. Showmanship is required in each species entered. In order to sell a market animal, the exhibitor must have shown in showmanship for that species.
18. No animals can be shown in both market and breeding classes.
19. All livestock on the Fairgrounds must be entered to show at the Canyon County Fair. No companion animals will be allowed on the Fairgrounds.
20. Exhibitors making entries and not exhibiting shall forfeit all fees paid.

HEALTH REQUIREMENTS

21. All animals entered must meet the health regulations listed in each species section.
22. All male large animals must be neutered completely. Intact bulls, bucks, rams, and boars are not eligible to be exhibited.
23. Prior to stalling / penning at the Fairgrounds all animals (beef cattle, dairy cattle, dairy goats, dogs, meat goats, poultry, pygmy goats, rabbits, sheep, swine) will be inspected by a veterinarian.

- If any indications or symptoms of contagious or infectious diseases are found, animal will be refused.
 - Decisions of the veterinarian(s) are final.
 - An exhibitor with an animal that has an obvious contagious medical condition must provide a Certificate of Veterinarian Inspection from the veterinarian treating the animal dated no more than 2 weeks from the Fair check-in date. The animal will be inspected by a veterinarian upon admittance into the Fairgrounds. If the veterinarian finds the animal unfit or potentially contagious based upon inspection, the veterinarian has final authority to refuse the animal into the Fair, even with the previous certificate.
24. Stall cards will be issued to each animal's exhibitor upon completion of the veterinarian inspection, and must be obtained before leaving the veterinarian inspection area. The stall card must be prominently displayed for each animal.
25. If at any time during the Fair any animal begins showing signs of a contagious or infectious disease, they will be inspected by a Show Official and may be asked to leave the Fairgrounds immediately. There will be NO veterinarian on staff.

EXHIBIT AREA

26. All exhibits, when assigned space, become subject to the control of the livestock superintendent(s). **RELEASE** - Exhibits will be released only during designated times. Every exhibitor must have a release form for each animal. Release forms may be picked up from the superintendent. Release forms will be collected by a Fair Official at the gate. Market animals sold through the sale are not released.
27. Stalls are assigned by species superintendents based on the number of market and breeding entries and space available.
28. Stall/Pen set up is available on Monday, July 21 from 5:00-8:00 p.m. and Tuesday, July 22 from 5:00-8:00 p.m. Vehicles are **ONLY** allowed on the grounds during set up on Monday. Vehicles are allowed on grounds to unload equipment and must leave immediately.
29. There will be no parking around the barns. You will be allowed time to bring in supplies. Do not drive vehicles through barns to unload. Any vehicles parked in unauthorized areas on the Fairgrounds will be towed at owner's expense.
30. Exhibit displays cannot block air flow. Exhibitors may be asked to remove their exhibit displays.
31. The building of additional pens at any location on the Fairgrounds, other than the pens or tie outs that are initially assigned is prohibited.
32. All Canyon County Fair exhibitors are responsible for their animals until the livestock area closes each night. Exhibitors are not allowed to stay overnight on the Fairgrounds.
33. All equipment (feed box, show and fitting equipment) must be brought in by each exhibitor before Fair begins and kept neat. Initial feed (hay and grain) may be brought in with livestock, but will not be kept in species areas. Due to space restrictions, feed and bedding must be carried in daily.
34. Extension cords will not be permitted in foot traffic areas.
35. Blocking stands and grooming chutes are to be set up in assigned areas only. Grooming areas must be kept neat.
36. Generators will be allowed each show day. Generators cannot be stored in livestock stalling areas. Generators must be kept out of walk ways.

37. Bedding must be shavings; no other type of bedding may be used. Shavings may be purchased on site from D&B Supply. ABSOLUTELY NO STRAW.
38. Exhibitors will be required to keep their spaces and stalls clean by removing any trash and litter and placing it in receptacles provided. Do not place stall cleanings in any trash barrel. Sweeping the aisle, cleaning up manure in the aisles, and keeping belongings out of the aisles is expected. Exhibitor must clean out all trash from their pen(s) and exhibitor area before checking out.

COMPETITION

39. IN ALL CASES - THE DECISION OF THE JUDGE IS FINAL.
40. Exhibitors must show their own animals except in extreme cases reviewed by a Show Official. Substitutions will only be allowed for the following reasons:
 - An exhibitor has two animals in the same class.
 - Conflicts with animals being exhibited at the same time in other species.
 - Sickness or physical injury documented by a physician.
41. Exhibitors are responsible for preparing his/her own animal for exhibition, but may receive assistance.
42. Any animal that cannot be kept under control by the exhibitor is a safety hazard. A Show Official may ask the exhibitor to remove the animal from the Fairgrounds. Exhibitors who let haltered animals go in the ring more than three times will be disqualified.
43. Care of all animals will be consistent with production practices and accepted standard. Abusive, fraudulent, illegal, deceptive or questionable practices in feeding, grooming, showing and management of animals will be grounds for dismissal from the Fair. No animal may be exhibited that has been given any sedative or illegal drug administered in any manner. Animals on medication must have a veterinarian slip. Exhibitors with market projects must observe all drug withdrawal periods and be aware of penalties associated with off label use of all drugs to be eligible to sell.
44. **DRESS CODE** - All exhibitors will wear one of the following in the show/sale ring. If an exhibitor's attire is inappropriate they will be asked to change.
 - A Canyon County Fair exhibitor t-shirt **OR**
 - 4-H Members:
 - A buttoned up, collared shirt or polo shirt, short or long sleeve
 - Long pants or skirt
 - Closed toe shoes
 - FFA Members:
 - An official FFA corduroy jacket, white buttoned up, short or long sleeve, and FFA tie/scarf
 - FFA collared shirt or polo shirt
 - Long pants or skirt
 - Closed toe shoes
 - Small Animal Exhibitors - May wear a long sleeve shirt.
45. The Canyon County Fair uses a modified Danish System of awards. The modified Danish System allows all exhibits to receive a purple, blue, red or white ribbon placing.
 - **Purple** - Superior. Exceeds the average standard. Indicates a near perfect exhibit.
 - **Blue** - Excellent. Best growth in project. Shows best understanding of subject and superior workmanship for age and experience. Shows leadership ability. Attractive project.

- **Red** - Better project growth. Medium personal growth. Better understanding of the subject. Neat exhibit.
- **White** - Satisfactory. Good project growth. Good understanding and workmanship.

46. All awards in the livestock department will be made on merits determined by the judge.

47. Thank you notes - All award winners are required to write a thank you note to award sponsors. Large and small animal award winners will be given their thank you notes during the shows and are due to the Livestock Show Office by the end of Fair.

MARKET LIVESTOCK SHOW & SALE REQUIREMENTS

48. Canyon County and Ada County 4-H and FFA members may sell only one market animal per year at one fair - either Canyon County Fair or Western Idaho Fair - regardless of the county in which they are enrolled in. Youth denied entry by the Owyhee County Fair and accepted by the Canyon County Fair will be allowed to sell one market animal at the Fair.

49. All market livestock exhibitors will be limited to two entries per species (*i.e., exhibitor may have two market beef, two market sheep, two market goats and two market swine*).

50. All male market animals must be neutered completely. No rams, bulls, bucks or boars will be able to show or sell as market livestock.

51. All animals eligible for the Market Livestock Sale will provide information on the origin of their animal to comply with USDA Country of Origin Label laws. Information will be collected at declaration.

52. Market animals will be insured at a set price as follows: Beef - \$1250; Swine - \$200; Sheep - \$200; Goat - \$200. Payout will be limited to funds on hand. Fees will be collected at declaration. These fees are: Beef - \$15; Swine - \$5; Sheep - \$5; Goat - \$5. Additional information is available at the Extension Office.

53. All market animal entries which meet the guidelines are automatically entered in the livestock sale.

54. Only animals that have been entered by the June 16 deadline will be eligible for final weigh-in. All market animals must have been declared by their species deadline. Animal to be weighed will have nothing on, except the halter. All market animals should be weighed at the Fair on full feed.

55. Animal should be clean and dry for weigh-in. Ear tags must be clean and readable for weigh-in.

56. If there is a question on weight, scales will be re-balanced and the animal will be re-weighed immediately. Once the animal leaves the scale weigh-in area there will be no re-weighs.

57. When a market animal does not make weight, it cannot be entered in a breeding class.

58. Exhibitors must have a market photo taken with all market animals at the time of their specified species photo times, regardless if they are selling that market animal or not. Failure to have a picture taken of all market animals at their specified species photo times will result in you not participating in the market sale.

59. All no sale forms are due within one hour after your final market class, if you have more than one market animal you are exhibiting. If you are participating in the Final Drive, which is a market class and exhibiting more than one market project, your no sale form is due one hour after the Final Drive. Failure to turn in no sale forms will result in you not participating in the market sale. No Sale forms are available and can be turned in at the Show Office. Animals listed on the sale order cannot be withdrawn.

60. Market Livestock Sale Order Rotation:

All Grand and Reserve Grand Champions will sell at the beginning of the sale in the same order as species rotation.

Poultry	Sheep	Beef	Goat	Swine	2025
Sheep	Beef	Goat	Swine	Poultry	2026
Beef	Goat	Swine	Poultry	Sheep	2027

The order of sale within each species will be determined by show ring placing - purple, blue, red, white.

61. Any animal exhibited in any market or meat bird pen class that received Grand Champion or Reserve Grand Champion must be sold in the Market Livestock Sale. In the event an exhibitor has won Grand Champion or Reserve Grand Champion in two or more species, exhibitor must designate one animal they wish to sell. Others will be removed from the sale order.
62. Exhibitors must be present and prepared to sell in sale order.
63. Only exhibitors that are in "good standing" within their organizations are eligible to sell an animal at the Canyon County Fair Market Livestock Sale.
64. No personal announcements concerning the exhibitor will be made during the sale.
65. The Market Livestock Sale Committee will not be responsible for collection of original purchase price of an animal.
66. The Canyon County Fair Market Livestock Sale is a terminal sale. Terminal is defined as a change of ownership. A project animal sold through the Canyon County Fair Market Livestock Sale cannot continue as a project animal in the current year.
67. Exhibitor is responsible for market animal until it is loaded on the truck. If an animal dies prior to that time, the circumstances will be reviewed by the Market Livestock Sale Executive Committee to determine payout, if any. Each exhibitor will plan to see that the animal is fed and watered prior to shipping. The Fair is not responsible for the security of any equipment (e.g., pig waterers, feed pails) left at the Fairgrounds. Disposable containers should be left for animals Sunday evening. Exhibitors may pick up left equipment on Monday from 10 a.m. to 1 p.m.
68. Any market animal sold through the Canyon County Fair Market Livestock Sale will be delivered to the packer by a member of the Market Livestock Sale Committee or their designated hauler.

Animals purchased for personal use may be picked up with appropriate bill of sale at the designated time set by the Market Livestock Sale Committee.

Non-Slaughter/Personal Use - Exhibitors will be given the opportunity to declare their animal as a Non-Slaughter/Personal Use project at the time of Fair entry, this declaration will be final.

Payment - Livestock must be paid in full by credit card or cash payment before the animal may be released. Payment must be made within 1 hour of conclusion of the Canyon County Market Livestock Sale. (Check will not be accepted as a form of payment.)

Delivery and Pickup - Upon payment confirmation, top bidder will be contacted by a member of the Canyon County Market Livestock Sale Committee to confirm purchase. Any animal not paid for by payment deadline will be sold to the floor buyer and top bidder will be invoiced for the difference between the floor price and the actual sale price. Animals must be picked up at the Canyon County Fair facility on Monday, July 28 between the hours of 8:30 a.m. to 10:00 a.m.

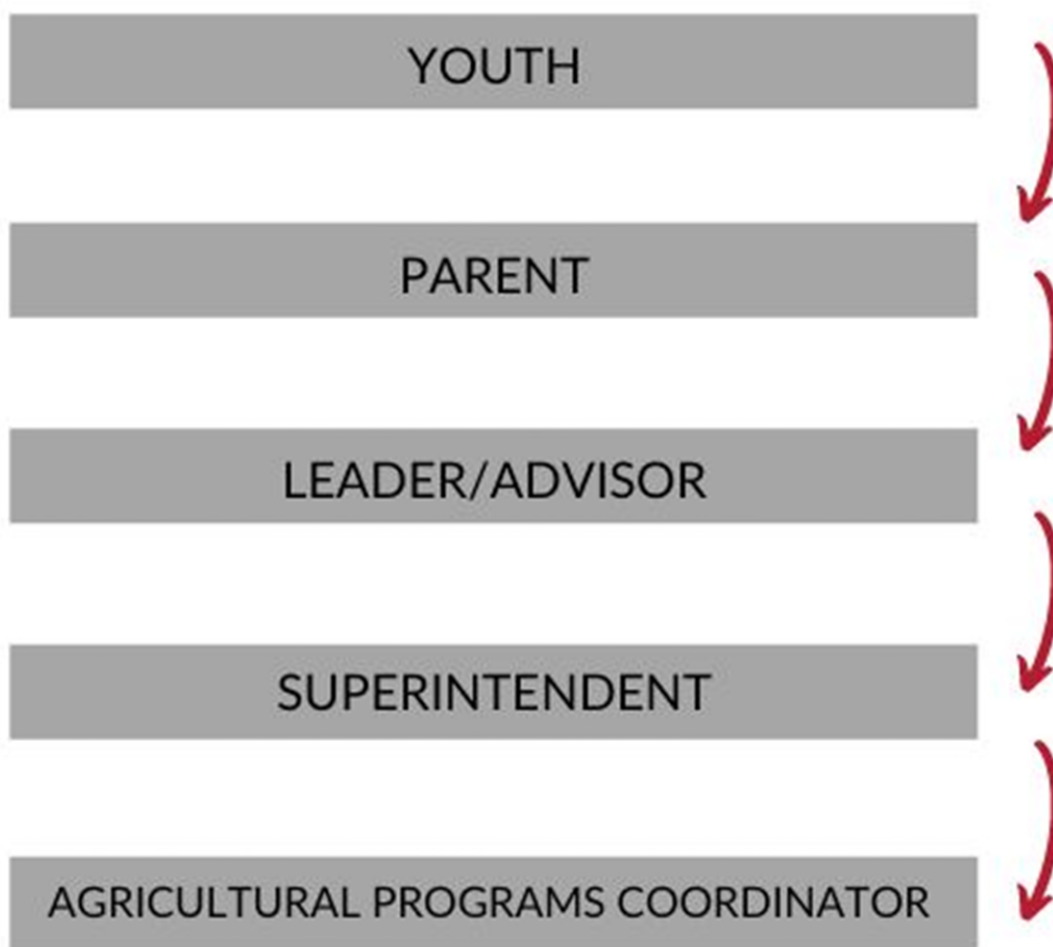
69. A deduction will be made from the total amount of the sale of each animal before checks are distributed. The amount deducted will be determined by the Market Livestock Sale Committee based on actual costs. This money will be used for expenses such as promotion, buyer recognition, sale operation, and trucking.
70. A \$2.00 fee for beef and a \$1.00 fee for sheep, goats and swine is assessed from each animal sold and these fees will be used to maintain a condemned carcass fund, which will be available to reimburse an exhibitor for any carcass condemned by the packer due to natural causes. Any carcass condemned from the effects produced by use of illegal or prohibited treatment or by neglect or abuse is the responsibility of the exhibitor. The exhibitor will not receive any funds from the sale of these animals.
71. Sale checks will be mailed to individual members, using addresses from the online fair entry system. Please verify your mailing address is correct. Checks will be released as soon as all money is received and the auction audit is complete. Checks will not be released until all support of that exhibitor has been paid to the Canyon County Fair Market Livestock Sale Committee.

PROTESTS

72. A protest form must be completed and be accompanied by a \$250 deposit which will not be returned. Protest must state plainly the cause of complaint or appeal and must be delivered to the Show Management immediately after the occasion that prompted the protest. Protests will be accepted prior to, during and within 2 hours immediately following the occasion that prompted the protest.
73. Judging procedures will not be interrupted for protest investigation. Depending on the basis of the protest, a decision may be withheld until a complete investigation has been conducted.

CHAIN OF COMMUNICATION

We all have a time when a question comes up that we can't answer on our own. We encourage you to ask those questions when they arise. Please follow the chain of communication below. If the person directly below you cannot answer the question, ask the next person. Keep going down the chain until your question has been answered.



Showmanship

1. Any member exhibiting an animal must compete in showmanship using their project animal.
2. The same animal may not be shown in both 4-H and FFA. If a member is showing in both 4-H and FFA in the same livestock species, he/she may not enter showmanship in both departments. The exhibitor must choose between 4-H and FFA Departments.
3. Showmanship class size will be based on showing limitations.
4. Superintendents may combine age divisions for showmanship if there are fewer than three entries in each department.
5. The same animal must be shown in any run-off classes that was shown in the qualifying class.

SHOWMANSHIP CLASSES

FFA - All FFA members.

Novice - Youth 8-10 years of age as of January 1, 2025 and first year showing any animal.

Junior - Youth 9-10 years of age as of January 1, 2025.

Intermediate - Youth 11-13 years of age as of January 1, 2025.

Senior - Youth 14-16 years of age as of January 1, 2025.

Advanced Senior - Youth 17-18 years of age as of January 1, 2025.

4-H Cloverbuds - Youth 5-7 years of age as of January 1, 2025. 4-H Cloverbuds may show cavies, dogs, poultry, pygmy or mini goats and rabbits that weigh less than the exhibitor. 4-H Cloverbuds may participate in Showmanship only. Participation only, not judged.

SHOWMANSHIP DIVISIONS

Grand Champion and Reserve Grand Champion Showman are selected for each species within the divisions listed below.

FFA - Selected from showmanship finalists in FFA classes.

Junior - Selected from showmanship finalists in Novice and Junior classes.

Senior - Selected from showmanship finalists in Intermediate, Senior, and Advanced Senior classes.

Round Robin

1. Round Robin exhibitors will use the same animal they used in the showmanship class. Changes must be approved by the Round Robin Superintendent.
2. All Round Robin exhibitors must receive a purple or blue ribbon in their showmanship class to be eligible for the Round Robin.
3. Round Robin exhibitors must accept/decline their participation in the Round Robin no later than Saturday, July 26 at 6:00 p.m.
4. Winners will be determined by the ability to show all types of animals/livestock.

SMALL ANIMAL ROUND ROBIN

SUPERINTENDENT: DEBBIE BUXTON

Grand and Reserve Grand Champion Showmanship winners in cavy, dog, poultry, pygmy goat and rabbit categories are eligible to participate. The highest placing eligible showman in the Small Animal Round Robin will be invited to represent Canyon County in the Super Round Robin at the Western Idaho Fair.

LARGE ANIMAL ROUND ROBIN

SUPERINTENDENT: TIM LOWBER

Round Robin Participants will participate in the following order: FFA, Junior, Senior. If the run-off class Grand or Reserve Grand Champion showman elects not to participate, then the 3rd & 4th place of the overall run-off class may participate.

FFA ROUND ROBIN

FFA Grand and Reserve Grand Champion Showmanship winners in beef cattle, dairy cattle, dairy goat, horse, meat goat, sheep and swine departments are eligible to participate. Horses will be shown if there is an FFA Showmanship class.

JUNIOR ROUND ROBIN

Showmanship finalists from novice and junior age classes shall return to compete for Junior Grand Champion. Junior Grand and Reserve Grand Champion Showmanship winners in beef cattle, dairy cattle, dairy goat, horse, meat goat, sheep and swine departments are eligible to participate.

SENIOR ROUND ROBIN

Showmanship finalists from intermediate, senior and advanced senior age classes shall return to compete for Senior Grand Champion. Senior Grand and Reserve Grand Champion Showmanship winners in beef cattle, dairy cattle, dairy goat, horse, meat goat, sheep and swine departments are eligible to participate. The highest placing eligible showman in the Senior Round Robin will be invited to the Super Round Robin at the Western Idaho Fair.

Livestock Judging Contest

Sunday, July 27 - Fair Building

8:30 a.m. Registration
9:00 a.m. Livestock Judging Contest

1. All contestants will judge classes of beef cattle, meat goat, sheep and swine.
2. Contestants:
 - 4-H: 4-H Extension Educators will determine 4-H rules and guidelines.
 - FFA: Area FFA advisors will determine FFA rules and guidelines.
 - Other: Canyon County Fair Junior Livestock Program exhibitors and adults are welcome to participate.
3. Talking: No talking will be allowed during the contest. Two warnings will be given to an individual and/or team and then disqualification and removal of individual or team will occur, resulting in loss of points.
4. 4-H State Teams: Each member will judge individually. Teams of four need to be designated at registration. Age of the individual is determined by their age on January 1 of the current year. All Jr. and Sr. participants will give oral reasons on one livestock class that is announced. The reasons will be given 20 minutes after the conclusion of the contest and should be under 2 minutes in length. All reasons will be scored, the reasons scores will count towards the overall score for teams. Scores will be posted at the Show Office. Only those giving oral reasons can qualify to compete at the State 4-H Livestock Judging Contest. The state contest is held at the Eastern Idaho State Fair in Blackfoot, Idaho. High scoring individuals who qualify to represent Canyon County must confirm state contest participation with Carrie Clarich, Canyon County Extension, by August 13.

1. General rules listed in this guide apply to all exhibitors.
2. **SHOW LIMIT** - The number of beef cattle exhibited at Fair will be limited to four per exhibitor (maximum of two market steers).
3. **ARRIVAL** - Stock trailers with beef cattle are to line up facing west on Stock Trail Road, enter Gate 4 and exit Gate 1 off of 22nd Avenue. Please bring all large equipment and feed on Monday, July 21, 5:00-8:00 p.m.
4. **RELEASE** - Exhibitors may begin removing tack and equipment by hand only at 8:30 p.m. Trailers will be allowed to enter the Fairgrounds through Gate 6 beginning at 10:00 p.m. and will load cattle and exit through Gate 5. No livestock will be allowed to move until the Fairgrounds have been cleared of patrons. **NEW for 2025:** Exhibitors **DO NOT** have to strip all bedding to the center of the aisle onto the asphalt, but are required clean all trash in exhibitor area before released. **BREEDING ANIMAL RELEASE** - Breeding livestock can be released early on Saturday, July 26, 6:00-8:00 a.m. Exhibitors must request early breeding release on their entry; however, approval of request is not guaranteed. Superintendents will assign exhibitors their release time between 6:00-8:00 a.m. Trailers will be allowed to enter the Fairgrounds through Gate 6 and exit through Gate 5.
5. **HEALTH INSPECTION** - Upon exiting the trailer and before going to their stalls, all beef cattle will be inspected by a veterinarian. Any animal that has an obvious contagious medical condition in which they have received a certificate of veterinarian inspection - dated within 2 weeks of the Fair from a veterinarian outside of the Fairgrounds - must present the certificate at check-in. The veterinarian at check-in will further inspect the animal to ensure that the certificate is still valid based on the present state of the animal's health. If the veterinarian deems the animal unacceptable, the animal will not be allowed to remain on the Fairgrounds. This decision will be final.

6. **HEALTH REQUIREMENTS, BRUCELLOSIS** - All female cattle four months of age or older must have a legible brucellosis vaccination tattoo. Non-vaccinated females over twelve months of age must have a negative brucellosis test within thirty days of entry into the Fair. Beef Superintendent will be checking and recording brucellosis tattoos at the Fair.
7. **BRAND INSPECTION** - The process for submitting your brand inspection will be changed for the 2025 Canyon County Fair. Please watch for updates from your Beef Superintendent for this process. Every steer is still required to have a brand inspection, even if it comes from the exhibitor's own herd. ONLY the process for submitting these will be changed.
8. **PROHIBITED FEED** - No feed containing animal protein by-products (meat or bone meal) may be fed to ruminant animals. Packers are requiring that a "Prohibited Feed" affidavit accompany all beef animals to be slaughtered. This document will be collected at the declaration deadline. No animal will be allowed to sell without this completed document on file with the Market Livestock Sale Committee clerk. Copies are available from the Canyon County Fair.
9. **HANDLING & SAFETY** - Beef cattle may only be walked prior to the Fair's opening, no later than 10:30 a.m. Please consult Beef Superintendent for designated areas. All beef animals may be shown with nose tongs or a ring and will not be penalized for it. All beef animals must have a neck rope in addition to a halter when tied, with the halter secured on the left side and the neck rope on the right. Each animal must be manageable by the exhibitor, with assistance if necessary. Upon arrival, a 3-person committee will inspect cattle as they are unloaded; animals deemed a safety risk will be sent home. If an animal poses a safety threat during any part of the Fair, it may be required to leave. Beef cattle that escape the Fairgrounds will not be permitted to return.
10. **FITTING REQUIREMENTS** - All beef in showmanship, breeding and market classes may be fit. Exhibitors are required to wash their cattle after showing and after the sale to remove adhesives. No products that alter the animal's natural color pattern (including dye, paint, or similar substances) are permitted. Market steers found with adhesives at the butcher may forfeit sale proceeds. Generators will be allowed on show days, but cannot be stored in livestock stalling areas or obstruct walkways.
11. **FEED & TACK** - No extra feed shall be stored in the stall areas due to limited space. Cattle must be monitored while being fed and watered. No buckets, troughs, or feed pans are to be left in the stalls throughout the day or when you are not supervising your animal.
12. **CLASS BREAKS** - Any class may be split at the discretion of the superintendent to accommodate size of classes or range of ages. **BREEDING CLASSES** - classes in each breed will be determined after all entries are in and based on total number that check in at Fair. A breed must have at least five head to have a division. If less than five head of one breed check-in at Fair, all of that breed's entries will be shown in the All Other Breeds class. In order to show in a breed show, registration papers must be provided to the Beef Superintendent upon check in. If an animal is not registered, it will be shown in the All Other Breeds class.
13. **TIE OUTS** - Cattle tie outs are available in the pens located behind the Caldwell Night Rodeo Arena. You must reach out to the beef superintendent to reserve tie out spaces. Email lauren patt94@gmail.com between June 1 and June 30 with the number of head you need tie out space for. If you do not email the Beef Superintendent during this time, you will not get tie out space. Cattle must be out of their tie out pens by 9:00 a.m. every morning, and pens and alleys need to be clean by this time as well. Please be aware that individual families need to reserve their own tie outs to ensure cattle that have lived together are the only ones in their tie out pen.

If you are reserving tie out space for a chapter/club, please designate the number of families or households you are reserving for. Cattle are released to tie outs daily at 9:00 p.m.

14. Halters will be picked up by the Beef Superintendent after Fair. Please watch for communication regarding when to pick these up from the Beef Superintendent.

The purpose of this information is for exhibitors to understand how their animal fits the beef industry's emphasis on customer satisfaction with the finished product. Special Beef Awards

Black Angus Ultrasound Carcass Award - The Idaho Angus Association sponsors two \$100 cash awards and plaques to the highest placing Black Angus Carcass and Ultrasound Black Angus Carcass in the state. Judging will be based from the CAB (Certified Angus Beef) formula. Carcasses meeting these criteria from the Canyon County Fair will be entered into the state contest by the Extension Office.

The Idaho Angus Auxiliary - Outstanding Angus Market Project - A rope halter is presented to either a 4-H or FFA member (only one award). The exhibitor must own the animal. Both quality and showmanship are to be considered. If there is not a Black Angus project entered then a crossbred animal is eligible providing it is a 50% Black Angus (verified Black Angus sire or dam). An exhibitor may receive the Outstanding Black Angus Market Project award more than once, but not two years in a row.

The Idaho Angus Auxiliary - Outstanding Black Angus Breeding Project - Steers are not eligible. An award is presented to either a 4-H or FFA member (only one award). The exhibitor must own the animal. (Both quality and showmanship are to be considered). If there is not a Black Angus Project entered then a crossbred animal is eligible providing it is 50% Angus (verified Black Angus sire or dam). An exhibitor may receive the Outstanding Black Angus Breeding Project more than once, but not two years in a row.

Western States Angus Auxiliary - The Western States Angus Auxiliary, will present an award to the outstanding 4-H exhibitor or outstanding FFA exhibitor. The selection of the winner is based on show ring placing of individual animals, placing in showmanship and educational display. The following point system must be followed.

Conformation point placing:

Grand Champion	40
Reserve Champion.....	30
First Place	20
Second Place.....	15
Third Place	10
Showmanship Participation.....	6
Education Display promoting the Angus Breed.....	25

If steers and breeding animals are both exhibited, points may be combined to select a winner. For breeding animals, the animal must be registered with papers. This is open to exhibitors with one or more breeding and/or market animals. Winning the award in previous years shall not exclude an exhibitor from winning again. For market steers this award should go to the highest placing predominately black steer, the sire must be Angus. It must be kept in mind that the purpose of this award is the promotion of the Angus breed. It is important therefore, that Angus breeding animals should take precedence over market animals.

Idaho Cattle Association Beef Award - The Idaho Cattle Association will present an engraved belt buckle to one FFA and one 4-H exhibitor for a Superior Beef Project.

- Award recipient should exhibit the best combination of performance, sportsmanship and citizenship.
- Award recipient should be enrolled in a beef project in the year the award is presented.
- The Superior Beef Award/belt buckle should be awarded to an individual only once.

The standing county awards committee in conjunction with FFA advisors and Extension Educators will determine the Superior Beef Award.

6. **ANIMAL IDENTIFICATION** - Before admittance to the Fair, all sheep (except wethers) must be identified with an official Idaho or Federal Scrapie Program tag. Breeders should be tagging their sheep. Check with seller if there is no tag.

7. **HEALTH REQUIREMENTS** - Animals that prolapse (prolapse that will not return to normal position without assistance) during the Fair will not be allowed to show or sell and must be removed from the Fairgrounds immediately. To help prevent prolapse it is recommended that the tail be docked at the distal end of the caudal fold in accordance with AVMA guidelines.

2. **SHOW LIMIT** - The number of hogs exhibited at Fair will be limited to four per exhibitor (maximum of two market hogs).
3. **ARRIVAL** - Stock trailers with swine will line up in the dirt parking lot along 22nd Ave and pull into Gate 1 and exit through Gate 4 to unload animals. **Animals must be clean before weigh-in, if not they will be turned away to be cleaned, then may return to the end of the line. Ear tags must be clean and readable.**
4. **RELEASE** - Exhibitors may begin removing tack & equipment by hand only at 8:30 p.m. Trailers will be lined up facing West on Stock Trail Road, swine will load out Gate 3. **BREEDING ANIMAL RELEASE** - Breeding livestock can be released early on Saturday, July 26, 6:00-8:00 a.m. Exhibitors must request early breeding release on their entry, request for early release may not be granted. Superintendents will assign exhibitors their release time between 6:00-8:00 a.m. Trailers will be allowed to enter the Fairgrounds through Gate 6 and exit through Gate 5.
5. **HEALTH INSPECTION** - Upon unloading, all swine will be inspected by a veterinarian and certified free from Atrophic Rhinitis, lice mange and other diseases. Any animal that has an obvious contagious medical condition in which they have received a certificate of veterinarian inspection - dated within 2 weeks of the Fair from a veterinarian outside of the Fairgrounds - must present the certificate at check-in. The veterinarian at check-in will further inspect the animal to ensure that the certificate is still valid based on the present state of the animal's health. If the veterinarian deems the animal unacceptable, the animal will not be allowed to remain on the Fairgrounds. This decision will be final.

- Any signs of weighted ear tags or evidence of past existence of such ear tags are determined to be not permissible and are grounds for disqualification.

Poland China

- Possesses Poland China breed character.
- Black with white face and switch (unless tail is docked). Three of the four legs must be white. May have occasional splash of white on body.
- Tail docking is permissible, eliminating that white point.
- Maximum of one black leg.
- Ears down.
- No evidence of belt formation.
- No red or sandy hair and/or pigment.
- No weighted ear tags or evidence of tampering with possible ear tags.

Berkshire

- Black and white with erect ears exhibiting Berkshire breed character.
- Must have white on face and tail, unless tail is docked. Three of four legs must be white.
- No solid white or solid black face from the ears forward.
- No solid black nose (rim of nose).
- White is allowed on the ears, but neither ear can be entirely white.
- One occasional splash of white may appear only on the body.

Chester White

- Possesses Chester White breed characteristics. Ears must be down and medium size.
- Solid white in color, no color on the skin larger than a silver dollar and no colored hair.
- Any signs of weighted ear tags or evidence of past existence of such ear tags are determined to be not permissible and are grounds for disqualification.
- Ears must be down and medium sized.

Landrace

- Must be white in color and possess Landrace Breed character. (Ears must be down)
- Must NOT allow any color hair other than white.
- Must NOT allow more than three spots of skin pigmentation.
- Must NOT allow any spot of skin pigmentation larger than one U.S. minted quarter.

Hereford

- To be eligible for registration they must have 2/3 white face and 2/3 red body.
- They cannot have any white beyond the middle of the shoulders and over the back.
- They cannot have any belt.
- They must have at least 3 white legs 1 inch high and must go all the way around the leg.

CROSSBRED

Barrows/Gilts of any coloration pattern or pigmentation are eligible for entry in this breed. Crossbred swine will split into two divisions as follows.

Light Cross

- Swine with diluted skin pigmentation of the following colors; sandy, rusty, orange or blue will be considered as Light Cross.

Dark Cross

- Swine with undiluted black, and/or undiluted red pigmentation, comprising at least 20% of total body area, shall be considered a Dark Cross.

3. Horse entries (class registrations) must be submitted online by June 16, 2025.
4. Patterns will be released on <https://www.canyoncountyfair.org/livestock/> on July 1, 2025.
5. Horse rules and class descriptions are available in the Canyon County 4-H Horse Show Classes and Rules Book. You may obtain a copy through the Canyon County Extension Office or at <https://www.canyoncountyfair.org/livestock/>.
6. Order of Precedence (Rule Books): In the event of inconsistencies within or between the Canyon County 4-H Horse Show Classes and Rules Book, Canyon County Fair Exhibitor Guide, and the Pacific Northwest 4-H Horse Contest Guide the following order will be used in such resolution: 1. Canyon County Fair Exhibitor Guide, 2. Canyon County 4-H Horse Show Classes and Rules Book, 3. Pacific Northwest 4-H Horse Contest Guide. All decisions will be at the discretion of the Canyon County Fair Horse Superintendents.
7. Round Robin exhibitors will show July 27, 2025. All Round Robin horses must arrive at the Canyon County Fairgrounds by 9:00 a.m. and remain on the grounds till 9:30 p.m. A stall will be provided for each horse; however, exhibitors are responsible for bringing their own feed and water buckets. Detailed unloading and parking instructions will be provided prior to Fair.
8. **All exhibitors in Idaho 4-H horse activities or events must wear an ASTM-SEI approved equestrian helmet whenever mounted on an equine, or are in a vehicle (cart, wagon, buggy, etc.) being pulled by an equine.**

9. Appropriate clothing attire is required at all times while mounted at the Fair Horse Show. See pages 5 & 6 in the Pacific Northwest 4-H Horse Contest Guide.
10. Youth who enter a class without the proper equipment for themselves and/or their horse will not receive a score. Refer to the Pacific Northwest 4-H Horse Contest Guide for requirements:

11. In the case of ties for high point awards, additional buckles will be awarded.
12. The Canyon County Fair Horse Show is not a gaited horse show and will not be judged as such. Review the Canyon County Horse Show Classes & Rules Book, page 22, for the command terminology that will be used at the Fair Horse Show.
13. All hardship requests will be considered on an individual, case-by-case basis. Please contact the Canyon County Fair Office for the Horse Hardship Policy and Petition Form.
14. If a shared horse is being shown by multiple exhibitors, only the primary project exhibitor will receive points, premiums, medallion classes, and high point awards.
15. Western Games
 - Points will not count towards high point awards.
 - Ribbons will be awarded for each class. Overall high point awards will be given out.
 - No buckles will be awarded for Western Games.
 - No whips/crops or whipping of the horse with any equipment is allowed. Participant will receive a no time if any whipping occurs.

2. **HEALTH INSPECTION** - Upon entry to the Fairgrounds, all dogs will be inspected by a veterinarian to ensure that no signs of disease are present. Dog exhibitors must also present the superintendent/veterinarian with a copy of animal's vaccination (including rabies, distemper & parvo) and health records. It is highly recommended that dogs be given the Bordetella vaccination & canine influenza vaccination at least one month prior to show. The canine influenza booster may be given just prior to show. Any animal showing signs of a health condition will not be allowed. This decision will be final.
3. All dogs exhibited must be crated or on a lead at all times, and kept in the dog exhibit area. No dogs are to be left unattended.
4. Exhibitors must show dog in showmanship. Obedience is optional.
5. Females in season must be reported to the superintendent and judge and may be shown in showmanship at the discretion of the judge. The judge must remove from competition, any dog that is not kept under control by its handler, any handler who interferes willfully with another competitor or his/her dog, and any handler who abuses his dog in the ring. If a dog or handler is expelled or excused by a judge, the reason shall be stated in the judge's book or in a separate report.
6. A chain collar "choke" is permitted; however, a show lead and collar are preferred.
7. Leads used in showmanship classes should be no longer than six feet and made of leather or nylon.

3. **HEALTH INSPECTION** - Upon entry to O'Connor Field House, all poultry will be inspected by a poultry specialist and certified free from lice, mites or disease. Birds suffering from disease or external parasites at check-in will be refused entry. Health decisions made by the check-in specialist may be verified by a veterinarian. This decision will be final.
4. All entries must include breed, variety, division, class, estimated birth date, sex and band number. Entries not completed correctly will be returned to the exhibitor.
5. All exhibits must have numbered leg bands matching the Fair entry form. Market Broilers will be assigned leg bands at the Fair during check-in time.
6. All exhibits must be health checked prior to caging. (No birds will be health checked without a numbered leg band.)
7. All poultry (except market pens) should be dusted prior to entry into the Fairgrounds. Registered pesticides can be obtained from your local feed mills or veterinary supply. Presence of lice or mites on fowl will be reason for disqualification and immediate removal.
8. Feet and legs should be clean and free from scaly leg mites prior to Fair entry.
9. A pair of ducks or geese consists of a male and a female in the same breed. A colored drake or gander and white duck or goose is not a pair.

The veterinarian at check-in will further inspect the animal to ensure that the certificate is still valid based on the present state of the animal's health. If the veterinarian deems the animal unacceptable, the animal will not be allowed to remain on the Fairgrounds. This decision will be final.
6. **ANIMAL IDENTIFICATION** - Pygmy goats registered through a recognized national breeding registry may be tattooed or micro chipped. Animals must have an identifying tattoo or tag (collar or ear) that corresponds with the entry form.
7. All pygmy goats must be dehorned. Breed standards will apply in all quality classes.
8. All goats must be in good health, physical condition and properly groomed for exhibit and show.

The veterinarian at check-in will further inspect the animal to ensure that the certificate is still valid based on the present state of the animal's health. 4. Any recognized breed may show.
5. Rabbits not entered in the proper class will be eliminated from that class and may be entered in the correct class if it has not been judged.
