Market Broiler Pen Declaration Instructions - DEADLINE MAY 26

Submit declarations at: canyonsale.fairwire.com

Step 1: Reserve Chicks - Contact Dunlap

Hatchery

- Call Dunlap Hatchery at 208-459-9088 to reserve chicks.
- Deadline to reserve chicks: **April 7**
- Reserve 5-10 Cornish Cross chicks (10 recommended).
- Hatch date for chicks is between May 12-19.
- If you source birds from another supplier, ensure the hatch date is between May 12-19.

Step 2: Chick Pick-Up Day

- Pick-Up Date: **Wednesday, May 19**, between 9:00 a.m. and 6:00 p.m.
- Pick-Up Location:
Dunlap Hatchery
4703 Cleveland Blvd.
Caldwell, Idaho 83606
- If sourcing birds from another supplier, chicks must be in your possession no later than Wednesday, May 19.

Step 3: Register

- Go to canyonsale.fairwire.com
- Click on the number one "Register" icon above the word "Welcome" 
- Enter livestock exhibitor's first and last name
 - **Please make sure the exhibitor name is spelled correctly.**
- Select "I am a new exhibitor or have yet to register this year"
- Select "Continue"
- You will be prompted to fill out your exhibitor information.
- Once you've completed the exhibitor information form, select "Continue".
- Review registration information and select "Continue" if it is accurate.

Step 4: Entries

- **Department:** select "Poultry"
- **Division:** select "Market Broiler - Market Broiler Pen - Declaration"
- **Class:** select "Declaration: Market Broiler Pen"
- **Breed:** Type in poultry breed (Cornish Cross)
- **Club:** Select your club (or chapter) name
- Select "**Add One Entry to Cart**" and select "Continue" when you are finished. (There is no fee for Market Broiler Pen Declarations, but you must add to your cart to complete the process.)

Step 5: Review

- Review the items in your cart
- Select "Check out"

Step 6: Confirm

- Review and type YES in the signature box
- Click "Submit"
- You will be prompted to upload receipt of payment for your chicks. Select "Upload Files" to attach your receipt.
- Select "Done" once you've uploaded your receipt.

Step 7: Finish

- Your declaration is complete and will be processed by the Canyon County Fair. Please remember that a Fair entry is also required and must be submitted by June 15 to participate.
